02. The above appointment will be governed by the service regulations of the Company prevailing and as amended from time to time.

03. The above appointment will be on probation for a period of two years and the probation period may be extended, for a further period of one year if the performance of Assistant Revenue Officer is not found satisfactory. The services of the officers, whose performance is not found satisfactory even during the extended period of probation, may be terminated at the end of extended period of probation as per erstwhile MPSEB's circular no. 01-05/1/93 dated 18.07.1989 read with circular no.01-13/3422/19 dated 01.07.2005 adopted by the Company.


04. During the Probation period and on confirmation, the Assistant Revenue Officer can terminate the employment by giving one month's notice or one month's pay (Gross) in lieu of notice to the Company. In that case the Assistant Revenue Officer shall be liable to pay the applicable bond amount as notified in the Service Agreement-cum- Surety Bond as per Rule No. 13 of circular no. MD/MK/R&T/F-165/12474 dated 17.12.2013 issued vide this office.

05. The above appointment of Assistant Revenue Officer is on provisional basis and subject to satisfactory verification of character antecedents by the police authority and caste, in respect of reserved category, by respective district administration. In case the character antecedent's report of the Assistant Revenue Officer is found adverse, his services are liable to be terminated then and there. On successful completion of probation period and on satisfactory verification of character and antecedent and caste verification, wherever necessary, the Assistant Revenue Officer shall be confirmed on the post of Assistant Revenue Officer by formal order and till then they shall be deemed under probation period.

06. The above appointments are without prejudice to the seniority.

07. The above mentioned employees are directed to report to the respective HR Manager, for necessary tagging and verification in PRAYAS.
