

The above appointment is subject to following Terms and Conditions:-

1. The candidates have to report at place of posting as trainee on or before 10th October 2017 failing which the appointment as AE (D)-Trainee will be stand cancelled and waiting list will be operated considering vacancy.
2. The company has the right to get any or all documents verified from the issuing authority for its authenticity and in case any of them are found false/forged/fake at any point of time in future or the above, formalities are not completed then in that case the appointment on the said post shall be terminated without giving further notice and legal action as deemed fit shall be taken.
3. The candidates have to submit Medical fitness certificate issued by District Medical Officer/ CMO or Sr. Medical Officer of the MPMKVCL Bhopal (If not submitted at the time of Document Verification).
4. The candidates have to submit police verification form as per annexure VI in two copies along with notarized affidavit on stamp paper worth Rs 100/ at the time of joining (If not submitted at the time of Document Verification).

5. The candidates shall have to undergo 6 months training as per the Company's Induction and Training Policy and have to complete the training successfully. If candidate fail to complete the training successfully the training period will be extended for 3 months for one time only. The appointment of trainees unsuccessful in training even after extension of 3 months will be terminated at the end of the extended training period..
6. Stipend equal to Base pay Plus Grade pay i. e. Rs. Rs. 15600 + Rs 5400 = Rs. 21000/ will be payable from the date of Joining at the place of posting as trainee.
7. The candidates have to execute Agreement cum Surety Bond on Rs 1000/ non judicial stamp paper duly sign by the surety as per the annexure III at the time of joining. The stipend will be paid only after acceptance Agreement cum Surety Bond by the General Manager Concerned.
8. During the training period, training will be governed by the company's "Induction and Training Policy 2013" and candidates will be eligible to avail leaves as per the policy.

On Successful completion of training the candidates will be appointed as Assistant Engineer (Distribution) from the date of successful completion of training a probationer at Base pay of Rs. 15600/ (in Pay Band-3) + Grade Pay of Rs 5400/ + DA and other allowances applicable at the time of appointment.
